## **EWTEC 2025 delegate Registration general terms**

- 1. No delegate shall be considered registered until payment has been received in full. Once payment has been received, an email confirmation including a receipt for payment will be sent.
- 2. Delegates should advise of any special access requirements at the time of registration.
- 3. The Organiser reserves the right to make alterations to the Event programme, venue, timings and format. See also paras 6 and 7 below.
- 4. Delegates' personal data will be processed in accordance with the Organiser's events and conferencing privacy notice.
- 5. Delegates who are no longer able to attend may, at no extra charge request the Organisers to transfer their registrations to others up until 4 September 2025. After this date, no transfer of registrations can be made.

## **EWTEC 2025 COVID-19/pandemic contingencies**

- 6. Whilst the Organiser intends the Event to take place at the Venue on the Dates, Delegates accept that this may not be possible due to the either Portugese or Worldwide restrictions on movement and gatherings in force from time to time as a result of a world event, e.g. COVID-19 pandemic.
- 7. For this reason, the Organiser reserves the absolute right to host some or all of the Event online instead of at the Venue, and has contingency in place for this to happen. If this applies then:
  - 1. (a) Delegates will be notified by email.
  - 2. (b) Delegates who have registered for a face-to-face ticket will receive a refund of 20% of the registration fee.
- 8. For the avoidance of doubt, Delegates will not be entitled to a full refund of the registration fee if they decline to attend any Event hosted online.

## Liability

- 9. Nothing in these terms and conditions seeks to exclude the Organiser's liability for death, personal injury, fraudulent misrepresentation or any other liabilities that cannot lawfully be excluded.
- 10. TheOrganiser'sliabilityforanylossordamagecausedorcontributedtobyitsbreachofcontractor negligence shall be limited to an amount equal to two times the registration fee paid or payable per Delegate.
- 11. The Organiser shall not be liable in respect of any:
  - 1. (a) indirect, or consequential losses, damages, costs or expenses;
  - 2. (b) travel expenses;
  - 3. (c) accommodation expenses;
  - 4. (d) subsistence expenses;
  - 5. (e) out-of-pocket expenses;
  - 6. (f) loss of actual or anticipated profits;
  - 7. (g) loss of contracts;
  - 8. (h) loss of use of money;
  - 9. (i) loss of anticipated savings;
  - 10. (j) loss of revenue;
  - 11. (k) loss of goodwill;
  - 12. (I) loss of reputation;
  - 13. (m) loss of business; or
  - 14. (n) loss of opportunity
